CPB, being the national institution through which major procurements are conducted, on behalf of the public bodies, has been attending with diligence, professionalism to its core business, as provided for, under the part III section 11 of the PPA with regard to vetting, evaluation, receiving and opening of bids, approving and issuing clarifications and addendum etc.

2022 has also been a year of transition as five new board members have been appointed to replace those outgoing, after completion of their non-renewable two terms. I take this opportunity to thank Mr. K. Mauremootoo, Mr. H. Rambhojun, Mr. S. Aboobakar, Mr. K. Bagwan and Mrs. S. Dindoyal for their top-class service to the Nation. As their replacement, we welcome Mr. S. Ragen, Mr. C. Jugroo, Mr. A. S. Sairally, Mr. F. Sénèque and Mr. D. Ramdhony who joined us as recently as August 2022. Understandably, there is a phase of learning curve to go through but overall, these various changes have no had any adverse effect on the performance of the Board

We also had a change at the level of the Chief Executive .We have a new Chief Executive Mr. D. Mannick, who was formally appointed in October 2022. Our manager Mrs. M. Pitois went on retirement in July 2022 and has not been replaced as yet.

However, there had been some difficulties encountered following the recent covid- pandemic as there had been huge volatility in prices and many bids received during the year had had to be cancelled because the bids received were in excess of the cost estimates. Furthermore, there had been a notable reduction in the number of bids received due to uncertainties.

This being the last newsletter of the year, we would like to thank all our partners for their most valuable collaboration. We earnestly hope that this collaboration will be further strengthened so that Mauritius will be a global reference for procurement.

The CPB, in its quest to continuously improve, had decided to train potential evaluators so that they will be classified as Certified Evaluators for selection as members of the Bid Evaluation Committee.

It is to be noted that the Procurement Policy Office is dispensing training to evaluators on how to navigate through the e-Procurement System. Section 6 (1)(b) of the Public Procurement Act which states that "*The Procurement Policy Office shall not in any way be* operationally involved in conducting procurement proceedings or resolving procurement disputes".

Consequently, the Central Procurement Board (CPB) in collaboration with the Civil Service College, Mauritius (CSCM) have decided to design and develop a 5-module online course together with on-line assessment for all potential candidates to be considered for selection as evaluators.

There will be a compulsory general module which will provide an insight into the bid evaluation process within the procurement cycle including the procurement legislation, methods and principles. Participants will be able to better understand the role and responsibilities of bid evaluators. The other 4 modules will include evaluation of works, goods, consultancy services and provision of other services in the public sector.

CSCM will mount the modules online on its platform and at the end of each module there will be an assessment (multiple choice). A certificate will be issued on successful completion of each module.

It is expected that the online training of the 5 modules will be launched by mid-February 2023 by CPB and CSCM in collaboration with the Ministry of Civil Service Affairs.

Prospective evaluators will be invited through the media to register and take the 5 - module course online and at the end of which, after successful completion including the online assessment will become certified evaluators.

Swaminathan RAGEN Vice Chairperson It all started around February 2021, when there was an urgent need for streamlining processes at the Central Procurement Board (CPB). The expected outcome of the implementation of this quality management system is to improve service delivery and enhance the CPB's customer experience.

So far, staff of the CPB including the Board Members had been sensitised to this ISO Standard. All the processes having a major impact on service delivery had already been drafted and associated risks assessed. Mandatory documents in conformity with ISO 9001:2015 had also been prepared and approved.

The Quality Management System implemented at the CPB is under scrutiny through the internal audit which is also a mandatory requirement. The result of this audit shall be presented to top management for further improvements in the daily activities of the organisation.

A Quality Management Manual which is a guide to ISO 9001:2015 will be ready by January 2023. An external certification body has already been approached for surveillance and certification purposes.

It is expected that Central Procurement Board will be ISO -Certified by mid-March 2023.

POST- COVID 19 IMPACTS ON PUBLIC PROCUREMENT PROCESS

The COVID-19 pandemic has brought about significant changes in the way economies function worldwide and in the public procurement process. To combat the pandemic, Governments across the world had had to impose restrictions on mobility (lockdown). These restrictions have led to significant disruptions in the supply chain and freight transport sector resulting in volatility in the prices of goods and services.

Bidders for capital projects are experiencing great difficulties to determine with certainty the prices to be quoted for the bids on account of escalation and instability in the prices of goods, services and freight charges. Thus, some bidders for capital projects prefer not to participate in the bidding process due to: -

- the volatility in the prices of goods and uncertainty in the supply of goods pertaining to the said projects; and
- the fact that in the event their bids are in excess of 25% of the estimated cost of the project, their bids will subsequently be rejected as provided in the Public Procurement Act 2006.

When the quoted prices of bids are more than 15% and less than 25% of the estimated cost, Directive 61 empowers a public body to negotiate with the bidders as a complimentary measure.

The Central Procurement Board (CPB) is bound by the provisions of the Public Procurement Act 2006 not to proceed with the award of the contract for the projects where the lowest evaluated bid is above 25% of the estimated cost of the project. Consequently, the bidding process has to be started afresh resulting in undue delays in implementation of projects.

For this calendar year, at least six projects had to be cancelled and relaunched.

A study of the evolution of Construction Price Index (CPI) has also revealed unprecedented patterns. The CPI which stood at 118.6 in October 2021 had made a weighty leap to 131.0 at the end of July 2022. This trend line further corroborates the fact that construction reliability is disrupted with challenges.

Nevertheless, it is important to mention that from July 2022 to September 2022, the Construction Price Index has increased at a relatively decreasing pace of 0.9% which might inspire confidence into a gradually stabilising market situation.

The road to full recovery after the COVID-19 crisis will likely be long and difficult. It is to be noted that the reported rate has recently risen and currently positioned at 4.50 points. Whether there is substantial stimulus or not, this is a critical time that could define the future resiliency and efficiency of the country's infrastructure.


